These families are also required to set up a direct debit account and pay their accounts on Monday for the week ahead.

Families not claiming the childcare subsidy enrol into a 48 week program and are required to pay a 5 week refundable bond prior to starting.

These families are also required to set up a direct debit account and pay their accounts on Monday for the week ahead.

We also charge a \$50 enrolment pack fee. This covers you for your child's electronic portfolio, display book portfolio and uniform.
